APPLICATION DEADLINE & CONFIRMATION

Must be postmarked by June 1st. Exhibit space will be assigned according to the order applications are received. *Early application is encouraged.*

JURIED ART To be eligible for awards and prizes, two images of your work must be submitted with your application. Send 300 dpi images on an unreturnable CD or email images to: NAFdirector@myfairpoint.net. The images should be representative of your work. You may submit different work to be judged on the day of the festival. By submitting images you are authorizing permission for us to use them for promotional purposes.

CHECK IN Exhibitors must check in between 6:30 and 8:30 at the KIOSK at Longley Square on Main Street to pick up information and booth assignments. Exhibitors must check-in prior to set up.

SET UP Main Street will be closed to traffic for the festival from 7am-5pm. Exhibitors must be set up and ready for business with cars parked in assigned lots by 8:30am. Vehicles will be allowed back on the street at 4pm for takedown. Tents and gear must be off the street by 5pm. Help will be provided if required.

DISPLAY SPACE, LOCATION, HOURS & TRASH REMOVAL Single space is 10'x10'. Exhibits will be open from 9am-4pm and exhibitors are expected to be open during those hours. You are responsible for your own trash removal and for providing your own equipment. Electricity is not available.
